

## Terms of Eligibility for ENTERTAINER with HSBC 2019

**You acknowledge and agree that by proceeding to register for an ENTERTAINER with HSBC 2019 account, you have read and agreed to these Terms of Eligibility.**

1. You will be eligible to sign up for the ENTERTAINER with HSBC 2019 if you :
  - a. hold a main HSBC credit card (except HSBC Corporate cards, and HSBC Debit cards) issued by HSBC Bank (Singapore) Limited ("HSBC") in Singapore; and
  - b. your credit card account is in good standing with HSBC.
2. The ENTERTAINER with HSBC 2019 is an application owned and operated by our third party supplier, The Entertainer Pte Ltd (**ENTERTAINER**) and not HSBC. HSBC is not a supplier of the products and/or services provided by any merchant featured on the ENTERTAINER with HSBC 2019 and will not accept any liability in relation thereto.
