



Terms and Conditions Governing HSBC Visa Infinite Credit Card Dining Discounts at Singapore Marriott Hotel (“Promotion”)

1. Offers are valid till 30 June 2021 for dine-in only and exclude set menus.
2. Payment must be made with the HSBC Visa Infinite credit card to enjoy the promotion.
3. Discounts are applicable on total food & beverage bill only, excluding government taxes and service charge.
4. Offers are not valid on the eve of and on public holidays, including special occasions specified by the merchant (including Mother’s Day, Valentine’s Day, Thanksgiving Day and 15 days of Chinese New Year (for Wan Hao only))
5. Prior reservation of at least 2 days is required and subject to availability. Please quote “HSBC Visa Infinite” prior to ordering, making reservations or payment.
6. Promotion is not valid in conjunction with other promotions, offers, privileges, discounts, vouchers, loyalty programmes and privilege card(s).
7. No splitting of bills will be allowed in case there are two or more HSBC Visa Infinite Cardholders dining at one table.
8. Discounts are applicable for maximum 10 people dining in the participating restaurants, the 11th guest and above will have to pay full price.
9. 50% discount is only applicable when there are 2 adult diners at a table subject to the following additional conditions for each outlet:
 - For Crossroads Café and Wanhao, a minimum order of 2 main course a la carte items is required for the 50% discount to be applicable. In the event that only 2 main courses are ordered for 3 diners and the 3rd diner orders a set menu, a 50% discount is applicable on the à la carte food bill. This applies to the other discount tiers, which will be determined by the number of diners and the corresponding main courses a la carte items ordered.
 - For Marriott Café, a minimum order of 2 buffets is required for the 50% discount to be applicable. In the event that only 2 buffets are ordered for 3 diners and the 3rd diner orders a set menu or a la carte menu, a 50% discount is applicable on the buffet food bill only. This applies to the other discount tiers, which will be determined by the number of diners and the corresponding buffet ordered.
10. Diners must each order a food item in order to enjoy the varying discounts.
11. Children ordering from the Children menu will not be considered in the headcount for discount. It will be considered as 1 adult headcount when a child orders a food item from adult’s menu/ buffet.
