



HSBC Plan With Us Home Loan Reward (“Promotion”) Promotional Terms and Conditions

1. This Promotion is valid from 2 January 2021 until 31 March 2021, both dates inclusive (the “**Promotional Period**”) or such other dates as may be determined by HSBC at its discretion.
2. This Promotion is offered to customers of HSBC Bank (Singapore) Limited (“HSBC” or the “Bank”) who meet the following criteria (“**Eligible Customers**”):
 - a. all main and joint borrowers to activate and utilize HSBC FinConnect via HSBC Singapore App to retrieve data from their HSBC and other banks’ account holdings;
 - b. apply directly through a Mortgage Specialist or are referred by their HSBC Relationship Manager to apply through a Mortgage Specialist for (i) a home loan or a home equity loan refinancing in respect of a residential property in Singapore or (ii) a home loan refinancing in respect of a residential property in Australia, with a minimum loan quantum of S\$/A\$200,000 (each, a “**Loan**”);
 - c. whose Loan application is received by HSBC during the Promotional Period and after the date of data retrieval from HSBC and other banks’ account holdings via HSBC FinConnect; and
 - d. accept the relevant facility letter in respect of the Loan (the “**Facility Letter**”) by 15 April 2021.
3. Eligible Customers will qualify to receive S\$80 cash credits (“**Reward**”). Regardless of the number of Loans and/or the total transactional value of the Loan(s), each Eligible Customer is entitled to only one Reward during the Promotional Period. For the avoidance of doubt, each customer relationship (whether sole name or joint names) shall be treated as a single Eligible Customer and shall receive no more than one Reward during the Promotional Period.
4. For the avoidance of doubt, the Promotion is not applicable to the following:
 - a. Restructuring of existing Loan(s) already taken out with HSBC;
 - b. Repricing of existing Loan(s) already taken out with HSBC; and
 - c. Bridging loans.

The Reward will be credited into the loan repayment account for the Loan within three (03) months from the end of the Promotional Period after HSBC determines in its discretion that all conditions under this Promotion have been met. For the avoidance of doubt, HSBC shall not be required to credit the Reward into any of the Eligible Customer’s other account(s) held with HSBC. Any request for early fulfillment of a Reward will not be granted or entertained by HSBC.
6. This Promotion is not valid in conjunction with the HSBC Home Loan Referral Programme, other offers, promotions, interest rate discounts or exclusive schemes, unless otherwise stated.
7. This Promotion is not valid for customers whose Loan(s) applications are referred to HSBC by third party agents or brokers.
